Purposes

We do not collect or use your personal data for purposes other than those described in the by Multi Instruments Instrumentation B.V. established processing purposes of personal data:

1. Registration for information, advice or a quotation.

When you send us e-mail or web form, this information is included in our e-mail archive and stored for processing, the data shall not be kept longer than necessary. Sometimes we ask you for personal data that is relevant to the activity in question. This makes it possible to address you in the right way and to process questions and answer your requests.

2. Conducting administration(s) of customers and suppliers.

For this we ask for the usual personal and contact details for identification in combination with data about the job and billing address. This information is kept for up to seven years (due to tax regulations).



Third parties

We use third parties in the execution of our services and activities, on the basis of a so-called processing agreement, whereby our principles for the protection and security of personal data are guaranteed.

Security
